Semi-Annual Cost Containment Report State Fiscal Year 2016: July 1 – December 31

Dear Sirs and Madams:

Section 5162.131 of the Revised Code requires the Ohio Department of Medicaid to report semiannually on the cost-containment initiatives related to the administration of Ohio's Medicaid program.

Following recommendations from the Joint Medicaid Oversight Committee, the Ohio Department of Medicaid has modernized its approach to the Semi-Annual Cost Containment Report. This document commences reporting for state fiscal year 2016 and provides status updates regarding the various cost-containment initiatives coordinated by our office.

Currently, there are 27 such items being led by the Department of Medicaid. While several initiatives have already been implemented in full following passage of the FY 16-17 biennium budget, the majority of efforts are categorized as being "In Progress" or in the "Planning Stage."

The statuses of these respective projects will be regularly updated through subsequent Semi-Annual Cost Containment Reports and testimony before the Joint Medicaid Oversight Committee.
